II. Qualifying Scores, J.O. Nationals, 2011

The meeting was opened with Dave Klein reviewing the approved changes with respect to Qualification to J.O. Nationals, made at the fall meeting at the USOTC, in Colorado Springs, September 16 & 17, 2010.

Those changes noted are:

“The MEQ, (Multi-Event Qualifiers), and Specialists are not to be included in the allotment. In addition set the number of participants for the 2011 JO National Championships to Level 10; 16-18 at 186, and the Level 10; 14-15 at 186.

Set the number of Level 9 participants at the 2011 JO National Championships at 294.

The total number of Level 9's and 10's for the allotment was adjusted to allow room for the MEQ (Multiple Event Qualifiers) and ES (Event Specialists) which are no longer counted in the allotment process. The MEQ and ES along with any Petitioned athletes will be added in after the allotment numbers.”

Dave then asked each of the members present to voice their view on continuing with the present Qualification scores or to adjust those scores.

All present agreed to stay with the present scores.
