For the purposes of this Participation Agreement (this “Agreement”), the athlete intending to participate (collectively with his or her parent or guardian, if the athlete is a minor) shall be referred to as “Participant.” USA Gymnastics, and its officers, directors, employees, agents, volunteers, and contractors are referred to as “USAG.” The camp or event in which Participant will participate shall be called the “Activity.”

- 1. Release, Waiver of Liability, and Assumption of Risk.** In consideration of the opportunity to participate in the Activity, Participant hereby releases and forever discharges USAG from any and all losses, liabilities, claims, obligations, costs, damages, and demands of whatever kind or nature, known or unknown, either in law or in equity, which arise or may hereafter arise from or are in any way connected with the Activity. Participant understands that this Agreement discharges USAG from, among other things, any and all losses, liabilities, claims, obligations, costs, damages or demands that Participant may have against USAG with respect to any bodily injury, personal injury, disability, death, illness, property loss, or property damage that may result from participation in the Activity. Participant understands and acknowledges that potential risks to health and personal property may be associated with participation in the Activity, and Participant voluntarily assumes those risks.
- 2. Compliance with USAG Policies.** Participant agrees to, at all times during the Activity, fully comply with the policies and procedures of USAG available on USAG’s website, as such policies may be amended, supplemented or otherwise modified from time to time by USAG in its sole discretion. These policies and procedures include, without limitation, USAG’s SafeSport Policy, Code of Ethical Conduct, and Bylaws.
- 3. Indemnification.** Participant agrees to defend, indemnify, and hold harmless USAG (as defined above) from any and all losses, liabilities, claims, obligations, costs, damages and causes of action, known and unknown, or proceedings of any nature (including attorneys’ fees) that may arise as a result of any and all injury, disability, death, illness, loss or damage to Participant’s person or property that may result from participation in the Activity, whether arising from negligence of USAG or otherwise.
- 4. No Refunds.** All consideration received by USAG under this Agreement, including any fee for the Activity, is not under any circumstances, including, but not limited to, the following force majeure events: (a) acts of God; (b) flood, fire, earthquake or explosion; (c) war, invasion, hostilities, terrorist threats or acts, riot or civil unrest; (d) government order or law; (e) action by any governmental authority; and (f) national or regional emergency.
